Arlington Urban Ministries serves clients who are homeless, exited from homeless and battered women's shelters, sick, elderly, unemployed and the working poor. In 2014 Arlington Urban Ministries served 1,037 clients.

NU2U is a retail thrift shop that sells gently used clothing at greatly reduced prices. They provide an income stream to the AUM Mission Office from the sale of 100% donated goods and an opportunity for many of the AUM clients to obtain clothing or other goods by using vouchers passed out at the Mission Office.
