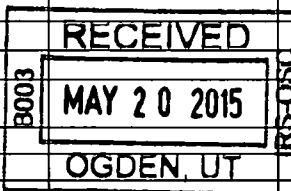

SUBSTANTIAL CONTRACTION STATEMENT

During the taxable year December 31, 2014, the Richard Family Foundation distributed \$201,000 to charitable organizations. This reduced the assets off the Foundation by more than 25%.
