	Texas Health Harns Methodist Hospital Fort Worth ("THFW") is a 656-bed,Magnet-designated regional referral center that has served the residents of Tarrant County since 1930 The hospital's services include cardiovascular services, high-risk and routine obstetrics and gynecology, orthopedics and sports medicine, neonatal intensive care, and trauma/emergency medicine THFW is also home to the 100-bed Texas Health Harris Methodist Heart Center The hospital was designated a Level II Trauma Center by the Texas Department of Health, named as a Cycle III Chest Pain Center by the Society of Chest Pain Centers for Percutaneous Coronary Intervention and designated an Acute Heart Failure Center It was also certified as a Primary Stroke Center by The Joint Commission, and the hospital earned its third Magnet Recognition Program Award for excellence in nursing services from the American Nurses Credentialing Center in 2014 More than 4,000 employees work at this hospital and nearly 1,000 physicians are practicing on its medical staff During the year, THFW had 177,525 patient days, 33,547 discharges, 184,426 outpatient encounters, 141,031 emergency room visits and 3,518 births THFW provides quality medical healthcare regardless of race, creed, sex, national origin, handicap, age, or ability to pay The hospital provides care to persons covered by governmental programs including Medicare and Medicaid for reimbursement that does not always cover the cost of providing the care Recognizing its mission to the community, services are provided to both financially indigent and medically indigent patients Community benefit is provided through many reduced price services and free programs to the community These services are essential to provide complete healthcare to the communities served THFW provides the resources and support to nurses participating in the Faith Community Nursing (FCN) program With special attention to congregations in underserved areas, the FCN program has covenants with over 50 congregations providing health screenings, health education and support for families of their congregations THFW is part of the system wide Child Automobile Safety Initiative whose mission strives to educate and raise community awareness about child safety

We treat each patient qualifying for charity care as a charity patient and no charges related to that patient are included in bad debt expense. The hospital is part of a consolidated system of hospitals which operate under the name Texas Health Resources (THR). THR's annual audit is conducted on a system-wide basis with a single consolidated audit report issued for THR and its affiliates. The audited financial statements of THR, which includes the activity of the organization, contain a footnote regarding Accounts Receivable and Allowance for Doubtful Accounts that reads as follows: Patient accounts receivable are reported net of estimated allowances for doubtful accounts and contractual adjustments in the balance sheets. The allowance and resulting provision for bad debts is based upon a combination of the aging of receivables and management's assessment of historical and expected net collections considering business and economic conditions, trends in health care coverage and other collection indicators for each of its major payor sources of revenue. Management assesses the adequacy of the allowance for doubtful accounts based upon historical write-off experience and payment trends by payor category. Patient accounts are also monitored and, if necessary, past due accounts are placed with collection agencies in accordance with guidelines established by management. For receivables associated with services provided to patients who have third-party coverage, the System analyzes contractually due amounts and provides an allowance for doubtful accounts and a provision for bad debts, if necessary (for example, for expected uncollectible deductibles and copayments, or for payors who are known to be having financial difficulties that make the realization of amounts due unlikely). For receivables associated with self-pay patients (which includes both patients without insurance and patients with deductible and copayment balances due for which third party coverage exists for part of the bill), the System records a significant provision for bad debts in the period of service on the basis of its past experience, which indicates that many patients are unable or unwilling to pay the portion of their bill for which they are financially responsible. The difference between the billed rates and the amounts actually collected after all reasonable collection efforts have been exhausted is charged off against the allowance for doubtful accounts. The System's allowance for doubtful accounts for self-pay patients (including allowances for charity care) increased from 96.0% of self-pay accounts receivable at December 31, 2013, to 96.1% of self-pay accounts receivable at December 31, 2014. In addition, the System's self-pay write-offs for bad debts increased from approximately \$294,476,000 for fiscal year 2013 to approximately \$310,000,000 for fiscal year 2014. The increase in write offs was the result of an overall increase in patient revenue in fiscal year 2014. The System does not maintain a material allowance for doubtful accounts from third-party payors, nor did it have significant write-offs from third-party payors.

Cost is determined by applying a cost-to-charge ratio (with costs determined in accordance with generally accepted accounting principles) to billed charges. The shortfall amount reported to the state of Texas for 2014 is \$99,675,171. Sch H requires a different method of calculating the Medicare shortfall shown on Part III, Lines 5-7.

At the same time, patients are provided with a Charity Care application and information flyer. The patient is informed that the hospital is a non-profit organization offering financial assistance to patients deemed medically or financially indigent. A Plain Language Summary titled "Getting Help Paying Your Bill" is included on the back of our patient statements. The plain language summary informs the patients of how to qualify for charity, how to apply for help, necessary documentation, and informs of THR's collection activities. The onsite financial counselors may assist the patient in completing the application and obtain available verification information. Once the patient is discharged, the counselors will continue to contact the patient to ensure all forms and verifications needed to file an application for governmental assistance and Charity Care have been provided. In certain cases, self-pay patients who are discharged before seeing a financial counselor receive both a phone call and a letter to alert them to the existence of the financial assistance program. Each bill sent for hospital services also contains contact information alerting patients that Texas Health has a charity care program.

A management fee is charged for the centralized services and reported on Form 990, Part VII, Section B as a professional services fee.
