SOME COLLEGE SCHOLARSHIP RECIPIENTS AND COLLEGE-AGED INTERNS ARE SENT TO THE YOUNG AMERICA FOUNDATION CONFERENCE AND ALL TRAVEL AND REGISTRATION FEES ARE PAID BY TEXAS RIGHT TO LIFE COMMITTEE EDUCATIONAL FUND. FOR THE ORATORY AND VIDEO CONTESTS, AN INDEPENDENT PANEL OF JUDGES SCORE THE STUDENTS ON A RUBRIC SCORE. THE LOCAL CHAPTER ESSAYS ARE JUDGED BY INDEPENDENT JUDGES AND ARE SCORED BASED ON THE STRENGTH OF THE ESSAYS. THE TEXAS RIGHT TO LIFE COMMITTEE EDUCATIONAL FUND CHOOSES A STUDENT FROM THE SCHOLARSHIP PROGRAM TO ATTEND THE NATIONAL RIGHT TO LIFE ACADEMY BASED OFF RECIPIENT'S INVOLVEMENT WITH THE ORGANIZATION AND AVAILABILITY. IN 2011, THE TEXAS RIGHT TO LIFE COMMITTEE EDUCATIONAL FUND STARTED A GRADUATE SCHOLARSHIP PROGRAM. STUDENTS ARE REQUIRED TO BE ENROLLED IN A TEXAS NURSING, MEDICAL, OR LAW SCHOOL, HOLD AN OFFICER POSITION IN A PRO-LIFE GROUP ESTABLISHED AT THE SCHOOL, ORGANIZE 3-4 MEETINGS EACH SEMESTER WITH A GUEST SPEAKER, HOST ONE SOCIAL EVENT EACH SEMESTER TO RECRUIT AND MAINTAIN MEMBERSHIP, VOLUNTEER TWO TIMES EACH SEMESTER WITH A PRO-LIFE GROUP, WRITE ONE ARTICLE (FOR THE TEXAS RIGHT TO LIFE NEWSLETTER) SUMMARIZING EFFORTS AT THE END OF EACH SEMESTER, IDENTIFY A NEW LEADER OF THE GROUP UPON GRADUATION, AND COMMIT FOR A MINIMUM OF TWO YEARS. STUDENTS RECEIVE DISBURSEMENTS OF THE SCHOLARSHIP (TWICE A SEMESTER) OF \$500. IN 2011, TEXAS RIGHT TO LIFE COMMITTEE EDUCATIONAL FUND BEGAN TO OFFER REGISTRATION SCHOLARSHIPS TO OUR HIGH SCHOOL SUMMER CAMP. STUDENTS ARE REQUIRED TO SUBMIT A WRITTEN APPLICATION FOLLOWED BY A PHONE INTERVIEW. THE SCHOLARSHIP IS THEN DECIDED BY A TWO PERSON PANEL.
