The competition is annual, and this is the second year where one veteran is awarded a \$2,000.00 scholarship, while the rest receive a \$1,000.00 scholarship.

The total consists primarily of expenses incurred in covering our President's trip to the COE Policy Seminar in Washington DC (\$2008.00) \$100 for registration fee for SVA Conference. Treasurer's Bond (\$90.00), government filing fee (\$30.00) and new laptop and software (\$816.00).

Annually, the Association sends its President to the Council for Opportunity in Education's Policy Seminar and Relations with the Department of Education conference in Washington, DC. The conference starts Sunday evening and lasts until Tuesday evening. The Department of Education meeting takes place the following morning. All the days are devoted to professional development and round-table discussions, except Tuesday, when the participants travel to Capitol Hill to visit with elected officials or their staffs, generally the veteran or education aide. During these visits our delagate's job is to inform the officials or their staff members about the existence of the U.S. Department of Education's program, Veterans Upward Bound, the lack of such programs in nearly twenty States, as well as the funding deficiencies in existing grant programs, and then seek their support in encouraging fellow lawmakers to make efforts to ensure that each State has at least one VUB program, while encouraging the ED Department to become more proactive in erasing the existing program discrimination found in nearly 40% of the Union. Our Association's visits to Capitol Hill are always helpful in educating elected officials about the existence and successes of our members' VUB programs, but beyond their verbal support, our visits have rarely translated into much more than that.
