Technology Education ProgramsSince 1989, Foresight has produced conferences known for their technical focus and multi-disciplinary environment. Foresight's Vision Weekends and Workshops feature candid, accessible discussions with leading thinkers on the future of emerging technologies. In 2014, Foresight held the Foresight Technical Conference. This conference featured several dozen leading scientists and technologists speaking on a variety of nanotechnology-related developments, research, and visions. Public outreach efforts feature lectures understandable by general audiences as well as specialists, and in 2014 included sponsorship of the Berkeley BioLabs event announcing an open source biological parts repository project. Focus areas for 2014 were the development and application of molecular manufacturing and transformative nanotechnologies, including a workshop on Directed/Programmable Matter for Energy, focused on pathways to comprehensive solutions for energy-related challenges. This experimental workshop was targeted for early-stage career researchers with guidance from senior nanotechnology scientists.

Policy Research and EducationForesight initiates public policy discussions, develops policy positions, briefs media and policy makers, and collaborates with others to help shape policy relating to emerging transformative technologies. Foresight serves as a member of American National Standards Institute's Technical Advisory Group to International Standards Organization's Technical Committee on Nanotechnologies.

PublishingForesight is a recognized leader in providing information on cutting-edge developments in nanotechnology through its website, ranked one of the top ten sites on the topic. In addition, Foresight publishes white papers, policy documents, the Foresight Guidelines, and other materials. In 2014, its Foresight Update e-newsletter provided the latest nanotechnology news to more than 14,000 subscribers in more than 100 countries, reporting on current topics, trends, research, media coverage, and policy. Highlights of the 2014 Directed/Programmable Matter for Energy workshop were featured in a publicly-accessible video on the Foresight website.
