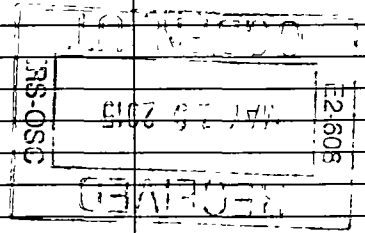

# Radford Foundation

## Grant Application Procedures...

To be considered for support, the Foundation strongly encourages organizations to submit a letter of inquiry *by email*. The letter should not exceed three pages in length (minimum font size 10). The letter can be attached to the email as a text or MSWord document, but do not include other large attachments.

The letter should include the following information:

- A brief summary of mission, history, and goals of your organization.  
  
(Note: The Foundation only provides funds to qualifying 501 (c)(3) tax-exempt organizations and in most cases only provides funds to organizations that are publicly supported charities within the meaning of Internal Revenue Code section 509(a). Any full grant application will need to include proof of your organization's status under these code sections.)
- A summary of the goals and specific activities to be supported by the Radford Foundation grant. Please also describe the population you intend to serve.
- A description of the outcomes you intend to achieve and how you will measure your success.
- Identify the key organization participants for the project and briefly describe their backgrounds.
- Budget figures: a) the total annual budget for the requested project, if project-specific support is sought; b) the amount of financial support requested from the Foundation for the year; c) the organization's total operating budget.

(Please note: You do not need to submit a line-item budget. We want to know the total amount of your Radford Foundation request relative to your total program and/or agency budget (For example, "The total youth sports equipment program budget is \$35,000. We are requesting \$5,000 in general operating support from Radford Foundation for the purchase of equipment. Our total organization budget for 2000 is \$350,000.)

The Foundation will acknowledge letters of inquiry by reply email. In rare instances the letter of inquiry will be sufficient to make a grant. In most instances, however, the Foundation will invite full proposals from a selected number of applicants. The Radford Foundation will not accept unsolicited full proposals.

Once the full proposal is received, the Board may have additional questions and/or need to make a site visit before deciding on an application. All applicants will be notified of the Board's decision.
