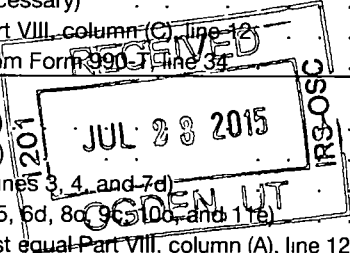

Our organization helps clients develop a plan to achieve or restore solvency and we connect clients with resources for continued recovery, growth, and long-term success. In 2014, we assisted over 650 individuals and we served as the hub for the local Carlton Complex fire relief while carefully leveraging \$90,000+ in cash donations and transporting several tons of donated goods to displaced families. In addition, we have partnered with "Feed My Starving Children", "Art with Heart", "Back to School Fairs" and other community projects to raise funds that support various efforts and programs
