We are currently working with three groups of students, their parents and community members in Sunflower County MS. Engaged 100 students in 20 workshop during the grant period. These workshops included You Day; Education Day; Health Day; Healthy Relationships Day; and Career Day. Engaged parents in a 1 day meeting in February in preparation for the student field trip. Executed a spring break summit and field trip to Orlando Florida for 93 students. Executed 3 days of training in Orlando, including financial literacy; leadership; relationship building; dressing for success; communication skills; afternoon fun in the parks. Executed a graduation ceremony and celebration in April. Graduated 93 additional students. Executed a graduation ceremony for the students. Hosted Black History Programs in February and March, 2014. Hosted 2 alumni meetings in April, and May, 2014. Hosted field trip to Arkansas in May, 2014 for 54 alumni students. Engaged 50 Pre-K to 6th grade students in educational and personal development activities. Hosted field trip to Memphis in June for 48 students. Hosted field trip to Choctaw, Ms in June for 48 students and 45 parents.

We operated the Sunflower County Food Pantry in Drew, Ms. We signed up to serve 100 families per month, but by the end of the year we were serving approximately 300 families per month.
