in 1984, the fourth St Pat's on this site above the Clark Fork River In May 2000, we became more involved with national medical research and education The hospital has 253 licensed beds Approximately 95% of our patients come from our 17-county service area Sponsorship In April 1873, the Sisters of Providence came to the Missoula valley to compassionately serve those in need, especially the poor and vulnerable They opened St Patrick Hospital, a not-for-profit mission, which quickly grew from a one-room structure to its current state-of-the-art medical center St Pat's continues to be sponsored by Providence Ministries, with a commitment to reveal God's healing presence to those who come to us for care HIGHLIGHTS * Mountain-Pacific Quality Health's 2014 Commitment to Quality Award was presented to Providence St Patrick Hospital Mountain-Pacific Quality Health's quality awards reflect continued expectations of engaging patients and families in improving care as well as top performance on quality indicators and system changes, as promoted by today's healthcare industry Strong leadership support is considered, since it is vital for achieving and sustaining excellent patient safety and improvements in patient care * Providence St Patrick Hospital was named one of the nation's 50 Top Cardiovascular Hospitals by Truven Health Analytics This is the eighth time Providence St Patrick Hospital has been recognized with this honor The 50 Top Cardiovascular Hospitals study evaluates performance in key areas risk-adjusted mortality, risk-adjusted complications, core measures (a group of measures that assess process of care), percentage of coronary bypass patients with internal mammary artery use, 30-day mortality rates, 30-day readmission rates, seventy-adjusted average length of stay, and wage- and severity-adjusted average cost * Providence St Patrick Hospital has achieved Magnet recognition by the American Nurses Credentialing Center's (ANCC) Magnet Recognition Program, which ensures that rigorous standards for nursing excellence are met Magnet is the highest recognition an organization can receive for nursing care as established by the ANCC, a subsidiary of the American Nurses Association (ANA) St Patrick Hospital is proud to be only one of two hospitals in the state of Montana to hold this prominent designation Out of the 6,000 healthcare organizations in the U S , fewer than 400 have achieved Magnet status * St Patrick Hospital Nuclear Medicine Department has been awarded the American College of Radiology (ACR) accreditation The Department has been accredited since 2002 The ACR awards accreditation to facilities for the achievement of high practice standards after a peer-review evaluation of its practice The program evaluates personnel qualifications, adequacy of facility equipment, quality control procedures and quality assurance programs All findings are reported to the practice via a comprehensive As medicine has changed, the institute has also evolved its focus to look more broadly at opportunities to make a difference through education in the health care environment with an emphasis on health, as opposed to health care specifically. This includes education of the public about important health care issues, education of undergraduates interested in the health care profession, and education of graduate level nursing, pharmacy and medical students in ethics, collaborative care and team building and conflict resolution.</p>

St Patrick Hospital conducts local assessments to make sure the needs of the community are met. The community board of directors oversees and approves the annual community benefit plan that addresses the health care disparities within the community. The community benefit plan is developed and reviewed annually to ensure that the proposed outcomes are being met. This plan is implemented in concert with others in the community to increase the accountability that we share with them to improve the health of our community and to not duplicate services.</p>

Providence also maintains a network of community ministry boards with responsibility for quality of care oversight, community relations, advocacy and community needs assessments. Providence has a consistent compensation philosophy for all of its employees, including our senior executives. Salaries for senior executives are reviewed by the Providence Board's Human Resources Committee and approved by the full Board of Directors, none of whom is a Providence employee. The Board retains an independent consultant each year to review salaries of those in the most significant leadership roles in the organization. Part of the consultant's role is to review an extensive array of compensation surveys of large, not-for-profit health care systems in the United States. Providence is one of the larger health systems in the country, and as such, the Board benchmarks executive compensation against other large, not-for-profit health systems whose revenue is similar to that of Providence. Base salaries for Providence executives are set at the median level of the market, as identified by the independent consultant and reviewed with the Human Resources Committee. Each year, the Board Chair conducts a formal performance evaluation of the President/CEO that considers input from the other directors and senior leaders reporting to the President. The evaluation is discussed with the Human Resources Committee and then a recommendation is made by the committee to the full Board. The Board Chair and the Chair of the Human Resources Committee also meet with an independent consultant to develop a salary recommendation, which is reviewed and approved first by the committee and then by the Board of Directors. Additionally, the President/CEO utilizes the market information provided by the consultant along with formal performance evaluations, to determine salary recommendations for other senior executives. This process includes a rigorous analysis of those recommendations with the Human Resources Committee as a part of the review and approval process. Performance incentives allow executives to earn additional compensation if they achieve specific organizational goals for furthering Providence operating commitments and strategic objectives - advancing the Providence Mission and core values, meeting benchmarks for charity care, achieving quality targets, delivering top-rated patient satisfaction, meeting employee satisfaction goals and reaching financial performance objectives. The Board of Directors conducts a thorough process to ensure performance incentives are aligned with appropriate practices for not-for-profit health care systems. The Board's process for executive compensation fully complies with IRS standards and mirrors the best practices recommended in the "Report to Congress and the Nonprofit Sector on Governance, Transparency, and Accountability" submitted to the Senate Finance Committee by the Panel on the Nonprofit Sector.</p>
