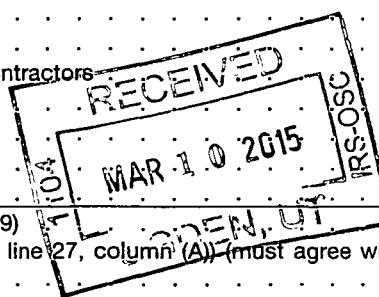

Mmametlhake Family Care Centre (MFCC), Mmametlhake, South Africa

MFCC provides help for those suffering from the consequences of HIV/AIDS of South Africa. The Centre employs Home-Base Care workers, Counsellors, Adult/Youth Awareness educators and a Children's Program Director. With increasing anti-retroviral treatments, more focus is on empowering/training Communities to identify/implement solutions to HIV/AIDS related issues. HIIHA supports MFCC financially and with volunteer teams, including Board Members, to provide specific services.

Tabitha Ministries - Pietermaritzburg, S. Africa

Tabitha operates two Orphanages and a training centre in the AIDS epicenter of the world. An estimated 50% of the local population is HIV positive. It employs 13 Home Based Care workers who look after 1200 AIDS clients, and 13 "Mobile Moms" who work with 6000 AIDS Orphans. Dire daily needs leave little time to address AIDS awareness. HIIHA supports Tabitha financially and with volunteer teams for special needs. HIIHA Board Members visit Tabitha on an annual basis.
