IN EARLY 2014, THE FOUNDATION'S CHAIRMAN PRESENTED A BILL TO THE COLORADO LEGISLATURE, TO ALLOW AN ALREADY EXISTING 10TH MOUNTAIN DIVISION SPECIALTY LICENSE PLATE TO BE RECLASSIFIED AS A CHARITABLE LICENSE PLATE. THIS CHANGE ALLOWS THE REPRESENTING CHARITY (THE FOUNDATION) TO REQUEST DONATIONS FROM PURCHASERS OF THOSE PARTICULAR LICENSE PLATES (THE GENERAL PUBLIC).

THE LEGISLATURE APPROVED THE BILL, HB14-1089, ON MAY 5, 2014. THE LAW CHANGE BECAME EFFECTIVE ON JANUARY 1, 2015. DONATIONS RECEIVED BY THE FOUNDATION FROM THIS PROGRAM ARE ACCOUNTED FOR IN A SEPARATE FUND FOR COLORADO AUDIT PURPOSES, AND ARE USED TO FUND PROJECTS RECOGNIZING THE 10TH
