The "Revenue" category above includes sales income from previous CRP titles (\$3,928) and all contributions received were "donor designated" to be applied to Cloud Ridge Publishing to cover initial expenses in the 2014 production of the Salish Sea book (\$33,390. for 233 image purchases, \$13,689. for book production professional services, and \$10,744. in book printing/shipping costs). The Salish Sea: Jewel of the Pacific Northwest was released by Sasquatch Books in March 2015.

2. Continuance of Cloud Ridge Publishing activities. In 2010 Cloud Ridge Naturalists added a publishing arm, Cloud Ridge Publishing, to further our educational and conservation efforts through the publication of books and other visual media that focus on areas of critical conservation concern. Initial book production expenses in 2010 were completely underwritten by a gift from the Executive Director. With the exception of a one-time royalty payment to the book's photographers, Bob Rozinski and Wendy Shattil, the author (Audrey Benedict) donates all proceeds from book sales of **Valley of the Dunes: Great Sand Dunes National Park and Preserve** back to Cloud Ridge Naturalists to support future publishing and educational projects. Expenses noted on this Form 990 for Cloud Ridge Publishing are for 2014 only.

***The major expenses for CRP in 2014 were for our new book, "The Salish Sea: Jewel of the Pacific Northwest. This book was published by Sasquatch Books in 2015 (March).

4. Cloud Ridge Naturalists offered 2 educational seminars to the general public in 2014. One of these (Salish Sea) was cancelled due to low enrollment. Payments (in full) to Pacific Catalyst for that seminar were applied to reservation deposits for 2015. Seminars continued to focus on terrestrial and marine ecosystems, with special emphasis on conservation issues associated with global climate change, evolutionary biology and adaptation, the impacts of pollution and general ecosystem health on marine systems, and the natural history of global ocean and nearshore environments. Our seminars provide the finest natural history education experiences available and highlight leading-edge environmental issues and research. The total number of participants in 2013 was 40. Our web brochure (www.cloudridge.org) describes the seminar offerings. A print copy of the brochure is attached and provides specific information on seminar offerings, instructor biographies, and most logistical details.

A Note on Expenses/Seminar Pricing: Program service expenses include Cloud Ridge's annual liability insurance, instructor honoraria (opt.), all group travel expenses (bus, van, boat, expedition ship, and plane), all meals, all lodging, all outfitting, special use fees, and operating permits. Cloud Ridge has no salaried employees and most instructors donate their teaching services. The Executive Director, who accompanies all trips, pays the same tuition that participants do and covers all instructor costs personally in most cases.
