RESIDENT OFFERINGS AT CHAPEL SERVICE AMOUNTED TO \$36,746 AND SUPPORTED EFFORTS SUCH AS THE DENVER RESCUE MISSION, COMPASSION INTERNATIONAL, DENVER URBAN MINISTRIES, SALVATION ARMY, STREET'S HOPE, STEP 13, AND HABITAT FOR HUMANITY, TO NAME JUST A FEW. OTHER ORGANIZATIONS BENEFITING FROM CLC CONTRIBUTIONS INCLUDE NELSON MINISTRIES FOR THE HOMELESS, PINEWOOD LODGE, THE CENTER FOR WORK EDUCATION AND EXCELLENCE, TOYS FOR GOD'S KIDS AND RENEW VOLUNTEERISM PROVIDED BY RESIDENTS, ASSOCIATES AND FRIENDS OF CLC GENERATED A VALUE OF \$1,079,444. BY FAR THE GREATEST PART OF THIS WAS ACHIEVED THROUGH THE EFFORTS OF OUR FORMAL VOLUNTEER PROGRAM. OUR INCREDIBLE VOLUNTEERS RECORDED NEARLY 40,000 HOURS OF SERVICE VALUED AT JUST SHY OF \$1 MILLION. ON BEHALF OF CLC, THE EXECUTIVE TEAM MEMBERS CONTRIBUTED OVER 1,000 HOURS OF SERVICE TO VARIOUS LOCAL ORGANIZATIONS AND CAUSES. CLC PROVIDED OVER \$373,000 IN COMMUNITY SERVICES. THIS INCLUDED BLOOD DRIVES FOR BONFILS BLOOD BANK, PROVIDING MEETING SPACE AT OUR COMMUNITIES AND HOME OFFICE TO NUMEROUS GROUPS, NEARLY \$17,000 RAISED FOR ALZHEIMER'S ASSOCIATION, \$8,000 FOR NATIONAL MULTIPLE SCLEROSIS SOCIETY AND \$23,653 IN SCHOLARSHIPS AND TUITION ASSISTANCE TO CLC ASSOCIATES. IN MISSION FULFILLMENT CLC PROVIDED \$1.48 MILLION IN UNREIMBURSED CARE AND SERVICE TO MEDICAID AND HUD ELIGIBLE RESIDENTS AND AN ADDITIONAL \$129,000 IN SUPPORT OF RESIDENTS VIA THE STEWARDSHIP FUND. THE STEWARD FUND RAISED \$138,000 THROUGH THE EARTHEN VESSEL DINNER AND AGED TO PERFECTION EVENTS. FINALLY, OVER \$23,000 WAS PROVIDED IN SPONSORSHIPS TO THE WORK OF LEADING AGE COLORADO (\$15,000), CENTRURE HEALTH AT HOME, THIRD CHRISTIAN REFORMED CHURCH, SHALOM CARES HOSPICE AND OTHERS.
