Project Self-Sufficiency assisted 183 single parents during fiscal year ended June 30, 2014. Each program participant was matched with an advisor from the PS-S staff who helps with goal setting, career planning, problem solving, resource acquisition, access to further education, counseling, and job search for those who are ready. Expenses to provide these services included salaries and benefits for program staff and program management, as well as supplies, postage, printing, office space and other expenses related to program operations. Additional expenses related to program activities and resources that address barriers to self-sufficiency are included in the other categories below. The Cars for Families program provides donated vehicles to some families enrolled in the Project Self-Sufficiency program. Donated cars are safety inspected and often repairs are made. Car titles are transferred from the donors to the organization and then to the families who are selected to receive a car. Volunteer and donated car repair is also available to families. The values of donated vehicles during fiscal year ended June 30, 2014 totaled \$107,589 and is included as an expense in this section. PS-S shows this value as income as well since the cars are awarded to families and are not sold for operating income. Also included is the cost of repairs that could not be done by volunteers. These funds come from multiple assistance funds available through Project Self-Sufficiency.

To improve family functioning, the program offers parenting and self-esteem classes. Children benefit from opportunities to take classes such as music lessons and gymnastics that are paid for through the Boundless Children's Fund. Each year back-to-school clothing is provided for the children. Holiday programs are offered each December.

Scholarships for single parents enrolled in the program help pay for academic expenses, child care while parents are in class, and other needs related to the ability of parents to attend classes and prepare for living wage employment. The expense total for this section include both direct aid and the cost of offering classes. Cars for Families expenses are excluded here and are included in 4c below.
