Placement of Children: In 2014, 455 Orphaned children under the age of 14 from Peoples Republic of China, Haiti, Latvia and the US were placed in American adoptive families homes. An Additional 372 families had add in the various stages pre-adoption process at the end of the year. On 12/31/2014 there were 1250 families in the adoptoin process and 1388 children receiving post adoption services.

4b (Code:) (Expenses \$ 749,766 including grants of \$) (Revenue \$ 526,321)
Childrens Charity Fund: a restricted fund dedicated to humanitarian assistance to orphanages. The fund has been used to purchase food, clothing, diapers, formula, educational materials, toys, and medical assistance. The Childrens Charity Fund sponsors over 800 children awaiting adoption in Foster Care programs, orphanages, and the 7 Lily Orphan Care Centers in the Henan Province of China.

4c (Code:) (Expenses \$ 276,221 including grants of \$) (Revenue \$ 223,599)
Family Development Services: To ensure the success of the adoption, CCAI developed post adoption services designed to assist the families with the bonding process,cultural and interracial differences. The Joyous Chinese Cultural Center conducts programs for pre-school through elementary school to teach Chinese traditions and to overcome issues associated with adoption. In 2013 a Tween program was implemented and serves over 50 local middle school aged children on a monthly basis. And the Adopteen Program serves over 200 adopted American teenagers each year with summer conferences and giving back trips where they spend time working and caring for children in the orphanages where they came from.
