Part II, Line 3	CCALT amended 6 conservation easements in 2014. One was an amendment to correct a scrivener's error in a legal description. The other 5 amendments reorganized reserved rights associated with the properties and altered building envelopes. One of these 5 also reorganized the subdivision rights associated with a property. All the amendments followed CCALT's Amendment Policy, complied with section 170(h) of the United States Internal Revenue Code, and were consistent with Colorado Revised Statutes sections 38-30.5-101, et seq. CCALT did not release, extinguish, or terminate any conservation easements in 2014. CCALT completed 10 conservation easement transactions in 2014. One of these was completed by restating an existing conservation easement deed to add additional acreage to the conservation easement, without significantly modifying its terms.
Part II, Line 5	The Colorado Cattlemen's Agricultural Land Trust (CCALT) is currently operating under a conservation easement stewardship, monitoring, and enforcement policy originally approved by the board in 1999 and renewed in 2010. Our policies ensure that CCALT will have the financial means necessary to continue our perpetual obligations to steward the conservation easements we have and will accept going forward. CCALT's policies also ensure that CCALT will have the necessary documentation to enforce each conservation easement going forward. This includes accurate baseline files as well as proper documentation of stewardship issues which have occurred in the past. Landowner requests for interpretation or changes to the deed of easement must be in writing. Notice of the exercise of a reserved right must also be in writing and in compliance with the notice provisions set forth in each deed of conservation easement. If a property changes hands, it is CCALT's policy to update our records and meet with the new landowner to ensure that they fully understand the restrictions set forth on their property. CCALT has a policy of monitoring every easement on an annual basis. Monitoring usually includes a visit to the property in person but may also include aerial or remote monitoring. CCALT's conflict of interest policy applies to the stewardship policy and no landowner may monitor their own property. Monitors of CCALT conservation easements will not make decisions in the field as to whether or not a situation is or is not a violation of the terms and conditions of the conservation easement. Instead, monitors will collect information on the item of concern. Upper level staff will then evaluate the infraction. If it is determined that the infraction is a violation, the board and legal counsel are notified and a course of action is set to correct the violation. It is the stated policy of CCALT to enforce all of the terms of our conservation easements. It is the intention of the organization to avoid litigation, if possible, in the enforcement of any violation of a conservation easement. However, legal action may be required and any legal action, including the filing of injunctions, on the part of CCALT requires the adoption of a resolution of the Board of Directors.
Part II, Line 9	The organization receives gifts of conservation easements, which represent numerous restrictions over the use and development of land not owned by the organization. The donated value of conservation easements is recorded based on the appraised value as determined by an independent appraiser. Easements are recorded as revenue when received and an expense is recorded for an equal amount whether the conservation easement is held by the organization or transferred to an eligible entity. The organization's policy for conservation easements is that the benefits flow through to the general public. The organization monitors activities on the land and enforces restrictions contained in both donated and purchased conservation easements. The organization holds 284 conservation easements covering approximately 448,920 acres in 42 counties throughout Colorado, and parts of Wyoming and New Mexico. Conservation easements are interests in land which possess conservation value but not economic value to the organization.
Part V, Line 4	Part V, line 4. There are three endowment funds held by the Land Trust. The Stewardship Endowment Fund provides funding for the ongoing and perpetual stewardship responsibilities accepted by the Trust for the conservation easements it holds. Donations to and investment income earned on the Stewardship Endowment Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure, at which time they are released from restriction. The Operating Endowment Fund consists of a donor-established endowment in which funds could not be expended until the assets reached a specific value, which occurred during 2014. Donations to and investment income earned on the Operating Endowment Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure, at which time they are released from restriction to the general operating fund to cover a portion of the cost of ongoing land trust operations. The Ron and Kitty Boedekker Peaks to Plains Conservation and Restoration Fund (the Boedekker Fund) consists of a donor-established endowment to assist ranch families in placing conservation easements on their property. Contributions to and earnings on the Boedekker Fund are recorded as permanently restricted net assets until appropriated by the Board of Directors for expenditure. The Land Trust is required to replenish the fund through mitigation payments and additional charitable contributions, with the understanding that the fund will contain at least \$100,000 at the end of each year.
Part X, Line 2	Management is required to evaluate tax positions taken by the Land Trust, and to recognize a tax liability if the Land Trust has taken an uncertain position that probably would not be sustained upon examination by taxing authorities. The Land Trust believes that it has appropriate support for any tax positions taken and that none would require recognition of a liability or disclosure in the financial statements. The Land Trust is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress. Management believes the Land Trust is no longer subject to income tax examinations for years prior to December 31, 2011.
