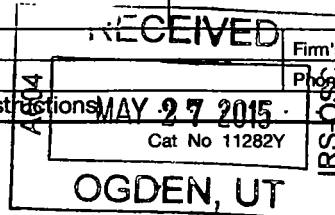

Approximately 6,700 people were involved as patrons or volunteers. Volunteers were recruited from three 501c3 organizations, to which event proceeds were distributed. The Fest is a major public relations event for the participating charities.

Organized and conducted the North American Beer Awards, a highly respected formal competition of craft beers produced in North America. There were nearly 1,400 entries judged by qualified volunteer judges. The event generates publicity for quality brewing and for the Mountain Brewers Beer Fest.
