As a part of the application process, agencies are required to submit a work plan document, budget narrative and budget document. Once an applicant is chosen, the submitted documents are revised into a contract as supporting requirements. Each month or reporting period, as applicable, the grantee submits regular reports about expenditures and adherence to program guidelines and their respective outcomes. At the end of each grant, the grantee submits a final report to account for all of the grant funds and the program or project. The grantee addresses the adherence to the original grant plan, any modifications, the program impact and the lessons learned. The agency maintains a permanent grantee file with all of their reports for future reference requirements.
