**Mental Health Interpreter Training to Groups to support mental health providers working within communities where concentrated numbers of monolingual Spanish speaking or Limited English Proficient (LEP) clients often do not receive adequate care due to a lack of bilingual/bicultural staff. With the tremendous growth of LEP populations nationally and the lack of bilingual/bicultural mental health professionals who can serve these communities, developing and enhancing capacity to address these populations is essential. Thus training interpreters is a critical step in eliminating disparities.**

**Hispanic Behavioral Health Trainings on Latino Cultural and Linguistic Competency. These workshops are designed to teach participants on the cultural considerations essential to serve New Mexico's Latino population and culturally informed increases the practitioners knowledge on how to better address the substance abuse and mental health conditions which are found in diverse Latino populations. These sessions are designed to provide an introduction and overview to service providers of the best cultural and linguistic practices for helping Hispanic, Latino and Native American clients dealing with substance abuse issues.**
