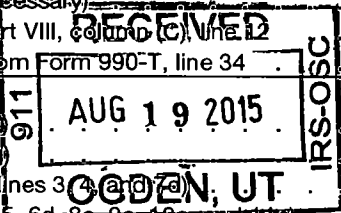

Working Classroom provided contracted employment to eight teaching artists and provided a mural opportunity to a new and upcoming artist.

Working Classroom provided contracted employment for six teaching artists and eight tech professionals.
