**FIFTH RESTATED ARTICLES OF INCORPORATION
OF THE FULL LIFE FOUNDATION**

As authorized by law, these FIFTH RESTATED ARTICLES OF INCORPORATION have been duly approved and supersede the original, the first, the second, the third, and the fourth Restated Articles of Incorporation, as provided and required by New Mexico Law.

ARTICLE 1

The name of the corporate foundation is THE FULL LIFE FOUNDATION.

ARTICLE 2

The Full Life Foundation is organized exclusively for charitable and educational purposes within the meaning of 26 United States Code Section 501(c)(3).

ARTICLE 3

- A. The Full Life Foundation may accept or acquire any property and engage in the transaction of any lawful activity or business for which a nonprofit corporation may be incorporated and maintain exemption from taxation under 26 United States Code 501(c)(3) solely for the benefit of residents of La Vida Llena, a not for profit charitable New Mexico corporation which operates a full care facility for elderly persons in the State of New Mexico, and to have all the necessary corporate powers enumerated in said laws and any and all laws amendatory or supplemental thereto, including rendering any form of aid for the benefit of the residents in the aforesaid facility to assure the continuing operation, financial stability, and rendition of services.
- B. The period of duration of The Full Life Foundation shall be coexistent with that of La Vida Llena, a not for profit New Mexico corporation, which may be perpetual. If that relationship is not perpetual, the following provisions shall apply:
 - 1. If corporate La Vida Llena is sold to another corporate operator providing essentially the same retirement services, The Full Life Foundation will retain the same relationship with the new operator.
 - 2. Upon dissolution of The Full Life Foundation for any reason, any remaining assets of the Foundation shall be distributed to an organization, similar in purpose to The Full Life Foundation, which is a qualifying organization under provisions of section 501(c)(3) of the Internal Revenue Code, as it may in the future be amended.
- C. Notwithstanding any provision of these articles, The Full Life Foundation shall not engage in any activities which are not permitted to be carried on by: (a) a

corporation exempt from federal income tax under the provisions of Section 501(c)(3) of the Internal Revenue Code of 1986 (or a corresponding section of a future federal tax code), or (b) by a corporation to which contributions may be deductible under Section 170(c)(2) of the Internal Revenue Code of 1986 (or a corresponding section of a future federal tax code).

ARTICLE 4

- A. The Full Life Foundation shall have no members.
- B. The affairs of The Full Life Foundation shall be conducted and managed by a Board of directors consisting of not less than nine (9) nor more than fifteen (15) positions/persons. Subject to the foregoing constraints the then existing Board of Directors of The Full Life Foundation may, by two-thirds affirmative vote, configure the Board positions in any manner acceptable to the Board provided that the following conditions are met:
 - 1. One position shall be filled by an ordained minister representing a denomination of a church involved in the founding of La Vida Llena.
 - 2. One position shall be filled by the then serving chairperson of the Board of Directors of La Vida Llena.
 - 3. One position shall be designated non-voting (ex-officio) and shall be filled by the Executive Director of the La Vida Llena Retirement Community.
 - 4. One position shall be designated non-voting (ex-officio) and shall be filled by the Chief Financial Officer of the Haverland Carter Lifestyle Group.
 - 5. Fifty-one percent (51%) or more of the voting director positions on the Board shall be held by residents of the La Vida Llena Retirement Community.
- C. Prior to serving, any person elected or designated to serve as a member of The Board of Directors shall file with the Secretary of THE FULL LIFE FOUNDATION an affidavit which consents to being a member of said Board of Directors.

ARTICLE 5

The address of the registered office of THE FULL LIFE FOUNDATION is 10501 Lagrima de Oro Road NE, Albuquerque, New Mexico 87111, and the Registered Agent at that address shall be the Executive Director of La Vida Llena or a person so designated by the Board of Directors of The Full Life Foundation to hold that position.

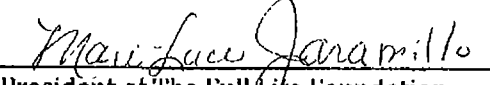

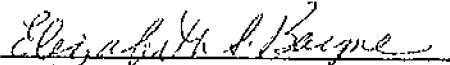
