This years 18th annual Phoenix Pride Parade brought together over 110 diverse Parade entries 2,000 individual participants from the metropolitan Phoenix area and beyond to approximately 12,000 spectators from the general public Participants included local, regional and national LGBTQ and LGBTQ-friendly individuals and organizations from the non-profit, private and public sectors Participation by government officials, government services, private corporations and celebrities continued to make spectators and the general public aware of their support for a prosperous LGBTQ community The 34th annual 2-day Phoenix Pride Festival continued to be a gathering created to educate the public about the existence and continuing civil rights battle of the metropolitan Phoenix LGBTQ community, as well as for the general public to celebrate the existence of its LGBTQ community The Festival had approximately 30,000 attendees and presented over 300 exhibitors and over 150 entertainment performances on 5 stages CONTINUED ON SCH O

In 2014, Phoenix Pride acquired One Voice Community Center, inc , the last remaining full service LGBTQ Community Center in Arizona Through Phoenix Prides management, the renamed Phoenix Pride LGBT Center has grown in physical space by two and a half times, and offers resources and services to clients from across the entire state Additionally, through Phoenix Prides management, the Center serves 400 percent more clients and offers 10 times more services since Phoenix Prides acquisition

Festival program fees helped fund over 60,000 in Phoenix Pride Partnership Grants for local non-profit organizations An additional 23,900 program funding went to the Phoenix Pride Scholarship Fund, also administered through the Arizona Community Foundation, from which 6, 5,000 college scholarships were awarded to local LGBTQ student applicants, totaling 30,000 This years 6th annual Phoenix Awards Gala was held in June following the Festival and the Parade This event focuses on recognizing and awarding key individuals from metropolitan Phoenix who have made a significant positive impact in the LGBTQ community We presented 8 Community Spirit Awards, 6 Parade Awards and recognized the 6 Scholarship Winners
