Programs

The Jewish Community Foundation of Southern Arizona (JCF) provides services for individual donors and non-profit organizations that house funds with the Foundation, including fund investment, management and reporting, field of interest research, and consultations with professional advisors. JCF works with individual donors to develop Legacy plans to fund endowments through testamentary provisions in their wills, trust, life insurance policies, etc. It also manages Donor Advised Funds and teen philanthropy funds (B'nai Tzedek Tucson).

JCF sponsors educational programs on estate planning, legacy planning and funding opportunities for donors and the community at large, along with continuing education seminars for professional advisors.

There were no significant changes to our programs in 2014.

Objectives for Fiscal Year Beginning January 1, 2015

- 1 Continue to fund worthy programs via grants and philanthropic distributions
- 2 Continue to promote endowments to support the Jewish community's institutions in perpetuity
- 3 Continue to promote legacy planning and encourage donors to support the organizations they care about
- 4 Continue an emphasis on working with local organizations to encourage planned giving among their constituencies

2014 Accomplishments

- JCF distributed grants to almost 400 charitable 501(c)(3) organizations that provide health, educational, cultural and social services. Grants made from net assets totaled almost \$4.6 million dollars.
- During the year, the Foundation development staff worked with hundreds of donors who created legacy plans and opened funds to support the organizations and causes they care most about now and long into the future.
- JCF presented educational workshops to attorneys, CPAs and financial planners on the topics of Arizona ethics, trust administration, administering unusual assets and other estate planning issues.
