In 2014, GCY celebrated its 16th year of service. Programs typically run from March through August. During that period in 2014, GCY facilitated 43 river education programs, serving 814 participants from across the country on 3,670 participant days - its largest program season to date. Programs took place on six sections of river in Utah and Arizona, including Grand Canyon. The GCY program continues to be one of the most affordable programs of its kind, charging up to two-thirds less than commercial river trips. Participants paid only 46 of the actual cost of operating the programs in 2014 the rest was funded by grants, contributions and special events. Additionally, almost 38,000 of financial aid was awarded to 51 participants during the year. Participants engaged in over 13,000 hours of community service during 2014, were required to earn a portion of the cost of their trip and presented educational projects of their choice related to the cultural or natural history of the Southwest. continued below

Board members with conflicts or potential conflicts are excused from discussions and from voting on related issues.
