Northern Arizona Senior Living Community, LLC dba The Peaks, a Senior Living Facility (The Peaks) located in Flagstaff, Arizona, is a comprehensive senior living and healthcare campus consisting of 58 skilled nursing beds, 96 assisted living units, and 39 bungalows The Peaks, Flagstaff, Arizona, is unlike any senior community in the county because it shares strong ties with the Museum of Northern Arizona, and Flagstaff Medical Center The Peaks provides its residents, as well as children in the area, with unique intergenerational activities that benefit the older adults and children alike Two of The Peaks residents and The Lodge executive director are docents of the museum, providing education on local history, and discovers of the Colorado Plateau to area schools, associations, the public and Peaks residents The Peaks provides assisted living, progressive memory care, rehabilitation, long-term care, and skilled nursing, with the opportunity for residents to "age in place " Residents are encouraged to remain in their apartment homes receiving assistance with activities of daily living through personalized levels of care The community was developed through a nonprofit partnership between Intergenerational Living and Health Care, the Museum of Northern Arizona and Northern Arizona Healthcare For the fiscal year ended December 31, 2014, The Peaks participated in vanous charitable initiatives such as the provision of discounted care through participation in the Arizona State Medicaid program We average 21 Medicaid patients in our skilled nursing facility on a daily basis and discounted their care by \$189,083 during the 2014 year In our lodge, we averaged 19 residents on a daily basis and discounted their care by \$597,321 during 2014 We have a partnership with the Museum of Northern Arizona (MNA) that consists of supporting an art collection within The Peaks and three museum docent programs The Peaks has come to an agreement with the Museum of Northern Arizona to issue memberships to all Peaks' residents We believe this art enriches the lives of our residents and the community as a whole Each month we support the museum with an \$825 monthly fee (Value \$9,900) We currently have a \$7,500 endowment at Northern Arizona University within the Behavioral and Social Science Department for scholarships to students who plan careers that would support seniors In addition, an endowment in the amount of \$15,000 was established with The Northern Arizona University's Foundation to be used for scholarships for degree advancement for registered nurses who aspire to earn a bachelor's degree in nursing The Peaks also gave a donation to the Northland Hospice by sponsoring a golf hole for \$2,500 during their 2014 annual fund raising golf tournament A gift of \$1,000 was presented to the Poore Clinic, a local clinic that provides free services for the underserved in Flagstaff A gift of \$1,300 was presented to Sunnyside Youth Cooperative, a Flagstaff group formed to perform community service to elderly, and homebound low income residents of Flagstaff

Accordingly, the Company has not recorded any reserves or related accruals for interest and penalties for uncertain income tax positions at December 31, 2014. The Company is subject to routine audits by taxing jurisdictions, however, there are currently no audits in progress for any open tax periods. The Company's open audit periods are the years ended December 31, 2011, 2012, and 2013.
