

**ASKNATURE:** The Biomimicry Institute's AskNature.org is the world's leading resource for understanding nature's survival strategies and their potential to inspire sustainable human designs. It's the only tool that gathers the world's biological intelligence, organizes it by function, and presents it in non-technical language. Since its launch in 2008, AskNature has attracted more than 1.8 million students, educators, and professionals spanning the design, engineering, science, and business fields. These users include design challenge participants focused on structure and behavior, materials scientists exploring nano- and micro-scale protein synthesis, entrepreneurs thinking about relationships and whole systems, research biologists documenting new natural phenomena, and more. They all rely on AskNature to inspire innovation, conduct research, and teach biomimicry. In 2014, the AskNature team launched a site redesign, informed by focus groups, to create a more intuitive user experience. Many volunteers contributed to deepening biological content on the site and the team secured new content partnerships, including with National Geographic. AskNature was featured alongside Michelle Obama and Jewel in National Geographic's Great Nature Project collections and was invited to guest blog monthly for National Geographic's Education blog. AskNature has been identified as "one

**DESIGN CHALLENGES AND EDUCATION PROGRAMS: STUDENT DESIGN CHALLENGES:** For the last five years, the Biomimicry Institute has worked with university students around the world through the Biomimicry Student Design Challenge (BSDC) to encourage innovative thinking inspired by nature that addresses real world problems. In 2014, the BSDC, which is now morphing into the Biomimicry Global Design Challenge to allow for independent professionals to enter, was focused on transportation. Over 200 teams from 22 countries registered, and over 100 submitted entries. Teams from McGill University (Canada) and the Universidad Autónoma de Yucatán (Mexico) tied for first place. The Canadian team's design uses air instead of water to regulate buoyancy, addressing problems with invasive species in the ballast water of trans-ocean cargo ships. The Mexican team's design is a novel human-powered vehicle that carries cargo and was inspired by the mechanics of motion in millipedes and snakes. One of the prior year's finalists for a water-themed SDC, a team from Artesis University College in Antwerp, was also named a finalist in the Global Social Venture Competition for its evaporative cooler inspired by the honeybee and designed to preserve fresh produce. Design Challenge Report: In response to a funder request, the Institute commissioned a

**BIOMIMICRY GLOBAL NETWORK:** The Biomimicry Global Network (BGN) is a network of networks that include regional and professional networks. Regional Networks host biomimicry activities catalyzed by individual champions and collaborative core groups organized around geographic location. Examples of projects include introducing biomimicry to local schools, creating biomimicry business incubators, and applying biomimicry to architectural and planning projects. Regional networks are independent-not legally affiliated with the Institute or each other. The Institute collaborates with these networks to create structures and systems that help spread biomimicry and catalyze its application. The Biomimicry Education Network (BEN) is the first professional biomimicry network. Members include educators who work with youth, university students, and informal student groups. The BEN website provides resources to help educators bring biomimicry into the classroom and facilitates the exchange of ideas and best practices. Biomimicry Fellows are educators within the BEN who are extensively trained in biomimicry and committed to bringing biomimicry to their respective institutions. University affiliates within this network have committed to prepare

TBI's and BGI's missions are uniquely aligned, therefore, in 2010, BGI and TBI entered into a Services Agreement to better meet TBI's educational objectives, further its exempt activities, and fulfill its broader mission to naturalize biomimicry in the culture by promoting the transfer of ideas, designs, and strategies from biology to sustainable human systems design.

Schedule L, Part IV - The Biomimicry Institute (TBI) shares resources and common costs in a mutually beneficial agreement with the Biomimicry Group (BGI).
