GRANT PROGRAMS FOR IMPLEMENTATION IN 2015

Community-based Skin Cancer Education/Prevention Grant Program

Implementation in 2015

One in five Americans develop skin cancer in their lifetime. Additionally, approximately 90 percent of nonmelanoma skin cancers are associated with exposure to ultraviolet (UV) radiation from the sun. A person receives nearly a quarter of their lifetime UV exposure by age 18 and the hours in the day with the strongest UV radiation occur during school hours. As exposure to UV radiation is an environmental risk factor that can be most easily minimized, skin cancer education for children, their parents and their teachers, coupled with prevention measures, are necessary for long-term community health. The Uriel Medical Foundation has coordinated the establishment of an interdisciplinary community-based team, including several local nonprofits, to research, develop, implement and evaluate an elementary school science-based skin cancer education and sunhat program. The Uriel Medical Foundation will serve as the coordinator and chief oversight, facilitating distribution of funds to eligible community-based nonprofits selected to be responsible for development of the community-based elementary school skin cancer awareness program, with anticipation of expansion in subsequent years.

Objective: To educate elementary students on the risks of sun exposure and methods to prevent skin cancer through a science-based education program and sunhat distribution program to be developed by local nonprofits and implemented in area schools. An evaluation process will assist the team in assessing program efficacy and potential improvements for subsequent years' expansion.

Program:

- Research of validated successful skin cancer awareness curriculums around the world, for use in local program development.
- Development of local curriculum program at local science nonprofit, focused on meeting state teaching standard requirements.
- Development and delivery of workshops to teach curriculum to elementary school teachers.
- Development of sunhat distribution program; anticipated sunhat distribution to 400+ students and teachers.
- Implementation in classrooms in multiple schools within school district.
- Evaluation of program to serve as mechanism to improve program in future years, focused on expansion throughout the community and state.

The Uriel Medical Foundation is the catalyst to establish the interdisciplinary collaboration of community nonprofits, schools and medical community, which is imperative to implementing a long lasting, far-reaching community program.

Community-Based Sun Shade Program

The Uriel Medical Foundation intends to build on its elementary school skin cancer awareness program by searching for granting opportunities and community partners for sunshade installations at schools and community facilities. Initial research will include site appropriateness, costs, maintenance, needs assessments, etc. This research is intended to begin in 2015, with implementation in late 2015 or early 2016.
