Prior to the July, 2014 Board Resolution to dissolve the foundation due to lack of funds,

there were 12 Headquarter new awards for a total debit amount of \$527,759.

Also, there were 7 Headquarter amendments to existing grant awards for a total debit amount of \$90,235.

During the year, there were greater than 75 Headquarter existing grant awards that funding extended beyond the September 2014 functional closing date and therefore, the award was closed by a credit amount of \$1,016,993.

There were closing expenses for a debit amount of \$119,526.

Finally, there were 3 Headquarter grant evaluation expenses for a debit amount of \$4,802.

Non grant program activities included sponsorship of conferences and seminars. The events provided hotels for meetings, meals and accommodation; paid for the leadership and panel of experts; and all cost for conducting the program. The participants were able to meet and to discuss openly about problems and solutions to local civil society in an effort to foster democracy and human rights in the Broader Middle East and North Africa region.
