AMENDMENT

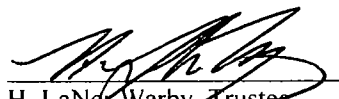
Pursuant to Section 5.01 of the Agreement, the trustees hereby amend the Agreement as follows:

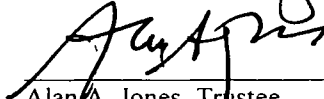

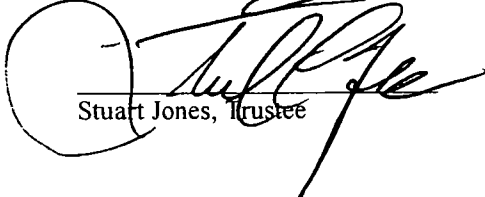
