Grants to Benefit Needy in General - Haiti- Clean Water: Reiser Relief, Inc. cooperates with Healing Haiti in a program designated to provide clean water to the poor in Haiti. Under this cooperative program, Reiser Relief, Inc. provided grants to Healing Haiti, which Healing Haiti used to operate a water truck that delivers fresh water to the poor in the slums of Cite Soleil, Haiti, bucket by bucket, six days a week, 52 weeks per year. Funds support local Haitian driver salaries, fuel and maintenance. The number one cause of malnutrition being a lack of clean water, this program brings lifesaving water daily to those in need.

Grant to Benefit Needy in General-Haiti-Schools: Reiser Relief, Inc. provided grants used to support two schools in Haiti - Reiser Heights in the poor, rural area of Lespinasse and Terra Promise in the slums of Cite Soleil, together educating over 1,000 students. We help by providing funds to pay teachers salaries so that the school fees can be low enough to allow even the poorest families to send their children to school. We have also built school classrooms, delivered water to schools, and purchased food, school supplies, benches, desks, uniforms and school supplies for these beautiful children of God.

Haiti Mission Trips - Reiser Relief, Inc. arranges and leads short term mission trips to Haiti to help raise awareness, create relationships, and foster desire to help the poor in Haiti. Participants are charged only the estimated costs for lodging, food, water, guides and transportation in Haiti. Participants are responsible for booking their own flight and paying their own airfare. Participants may also volunteer in various assistance activities conducted in Haiti.
