

We, the undersigned natural persons of the age of twenty-one years or more, acting as officers of the Las Vegas Global Economic Alliance (the "Corporation"), a nonprofit corporation formed under Chapter 82 of the Nevada Revised Statutes, adopt the following amended Articles of Incorporation for such Corporation.

**1.**

The name of the Corporation is Las Vegas Global Economic Alliance.

**2.**

The principal office for the transaction of the business of this Corporation shall be located in the County of Clark, State of Nevada.

**3.**

The Corporation shall be organized for the promotion and advancement of civic, commercial, and industrial activities in the State of Nevada and particularly in Clark County thereof, and for the benefit of such community as a whole; and will collect, organize, reproduce and disseminate information for the purpose of this corporation, which is to establish, operate and maintain one or more federally approved foreign trade zones within the State of Nevada for the purpose of enhancing economic and business conditions, and expanding international trade opportunities for the business and citizens thereof.

**4.**

The Corporation is organized for nonprofit purposes, shall not issue stock, and shall not engage in any business, trade, avocation or profession for gain or profit; and no part of its net earnings shall inure to the benefit of any member, director, officer, or individual.

The conditions, regulations, terms and conditions of membership and the rights, voting power and other privileges of the classes of members shall be determined and fixed by the bylaws.

**6.**

The period of duration of this Corporation shall be perpetual.
