Line 16 - Credit Card Debt, accounting fees, miscellanse snacks bought for canteen customers, reimbursement for mileage traveled locally on Canteen business including to pick up canteen supplies and make deposits.

Line 26 - Credit card, reimbursements for travel to and from Hospitals, Memorial Services, Convention Registration, and convention expenses.
