BYLAWS OF THE ADVISORY BOARD OF THE NEVADA DONOR NETWORK, INC.

Revised:
January 2014

ARTICLE I -NAME

The name of the corporation is the Nevada Donor Network, Inc. (hereinafter referred to as “the NDN”) a non-profit corporation established under the laws of the State of Nevada. As required an Advisory Board has been constituted to perform those purposes as set forth herein below.

ARTICLE II – ADVISORY BOARD AUTHORITY

Section 1. **AUTHORITY AND PURPOSE.** The primary purpose of the Advisory Board is to make recommendations to maximize organ and tissue donation in the Nevada Donor Network’s (NDN) Donation Service Area (DSA) as defined by the Centers for Medicare/Medicaid Services (CMS). Specifically, the Advisory Board is to identify and make recommendations to remove barriers to organ and tissue donation in keeping with best practices in the field.

The Advisory Board has authority to recommend policies for the following:

- (A) The procurement of organs and tissues.
- (B) Effective agreements to identify potential organ donors with the majority of hospitals in the NDN DSA that have facilities for organ/tissue donation.
- (C) Systematic efforts, including professional education, to acquire all usable organs from potential donors.
- (D) Arrangements for the acquisition and preservation of donated organs and provision of quality standards for the acquisition of organs that are consistent with the standards adopted by the Organ Procurement and Transplant Network (OPTN, the government contractor), including arranging for testing with respect to preventing the acquisition of organs that are infected with the etiologic agent for acquired immune deficiency syndrome.
- (E) Appropriate tissue typing of organs.
- (F) A system for the allocation of organs among transplant patients that is consistent with the rules and requirements of the OPTN.
- (G) Transportation of organs to transplant hospitals.
- (H) Coordination of activities with transplant hospitals in the NDN DSA. (I) Participation in the OPTN.
- (J) Arrangements to cooperate with tissue banks for the retrieval, processing, preservation, storage, and distribution of tissues as may be

appropriate to assure that all usable tissues are obtained from potential donors.

(K) Annual evaluation of the effectiveness of the OPO in acquiring organs.

(L) Assistance to hospitals in establishing and implementing protocols that maximize donation.

(M) The Advisory Board will review and recommend organ recovery clinical policies for approval. The Governing Board will consider Advisory Board recommendations, review and approve all clinical policies and procedures related to organ recovery to ensure compliance with CMS, OPTN/UNOS regulations and accepted standards of practice.

The Advisory Board has no authority over any other activity of the NDN.

Section 2. **MEETINGS.** The Advisory Board shall meet not less than four times each year. The Advisory Board may meet separately or in joint session with the Governing Board. The annual meeting will be a combined meeting of the Governing and Advisory Boards. It shall be held in November or December of each year and include an orientation program for Board members that includes Corporate Compliance, a review of CMS, OPTN/UNOS regulations and Conflict of Interest issues

The Chair may call additional meetings as needed to meet the needs of the organization. Such meetings require at least ten (10) days notice to the membership. The date, time and location of the meeting will be determined by the Chair. Members may attend meetings via conference call or other electronic media. Voting may take place via telephone, fax, e-mail, any other official NDN portal, or other means.

Section 3. **QUORUM.** A quorum shall consist of a simple majority of the voting members of the Advisory Board.

Section 4. **AGENDA.** A published agenda will be provided to the Advisory Board and distributed at least seven (7) days prior to a regularly scheduled meeting. Board members may contact the Advisory Board Chair or their designee to add additional items up to fifteen (15) days prior to the next scheduled meeting. A final Agenda must be published and distributed to the Advisory Board within seven (7) days of the next regularly scheduled meeting.

Section 5. **RULES.** The Advisory Board and all committees (if any) related thereto shall follow Roberts Rules of Order.

Section 6. **COMMITTEES.** The Advisory Board may create temporary committees as needed

to further the purpose of the Advisory Board. Permanent committees may be created upon approval by the full Advisory Board and with the advice and consent of the Governing Board.

ARTICLE III - ADVISORY BOARD

Section 1. **ADVISORY BOARD COMPOSITION.** The Advisory Board shall consist of a minimum of nine (9) but not more than twenty-five (25) voting members. The Advisory Board shall be composed as follows:

- (A) One or more hospital administrators.
- (B) One or more representatives of tissue banking.
- (C) One or more representatives of voluntary health associations in the NDN service area.
- (D) One or more representatives of either intensive care or emergency room personnel.
- (E) A physician with knowledge, experience, or skill in the field of human histocompatibility, or an individual with a doctorate degree in biological science and with knowledge, experience, or skill in the field of human histocompatibility.
- (F) One or more neurosurgeons or other physicians with knowledge or skill in the field of neurology.
- (G)A practicing transplant surgeon from each transplant hospital in NDN's Service area.
- (H) One or more representatives of eye banking. (I) An organ donor family member
- (J) Members who represent the general public residing in the NDN's service area (define) which may include but are not limited to, transplant recipients, individuals from the fields of law, theology, hospital administration, ethics, health care financing, computer sciences, economics, sociology and behavioral sciences, among others.

The Chair of the Advisory Board or the Chair of the Governing Board may appoint additional, nonvoting members as needed or desirable from time to time to carry out the functions of the Advisory Board. Appointed members do not count in the establishment of a quorum, until such time as they have been voted in as official members of the Advisory Board

Section 2. **OFFICERS.** The officers of the Advisory Board shall consist of the Chair, the Vice-Chair, and the Secretary. Officers are elected biennially by the duly elected members of the Advisory Board.

Section 3. **DUTIES AND POWERS OF OFFICERS.** The officers shall perform the duties prescribed by, these Bylaws, and the parliamentary authority adopted herein and those assigned by the Board. These duties and powers shall include but not be limited to the following:

- A. The Chairperson shall:
 - 1. Preside at all meetings of the Board.
 - 2. Make a full report of the year's work at the annual meeting of the Board.
 - 3. Advise committee chairpersons regarding selection of members.
 - 4. Act as an ex-officio member of all committees.
- B. The Vice Chair-Elect shall:
 - 1. Assume such duties as may be designated by the Chairperson or the Board.
 - 2. Assume the duties of the Chairperson and perform any and all duties of the Chair in his/her absence or disability.
- C. The Secretary shall:
 - 1. Cause to be kept a record of the minutes of all regular, special, and Committee meetings and attest to the same with the Secretary's signature.
 - 2. Receive the reports and recommendations made by the standing committees at each regular meeting of the Board.
 - 3. See to the giving and serving of all notices of the Board and shall have such other powers and perform such other responsibilities as the Board may from time to time determine.

Section 4. **TERM OF OFFICE.** The term of office will be staggered in two year increments with one-half of the trustees' terms expiring in the first year and the second half in two years. Every year thereafter, one-half of the Advisory Board will be elected. Advisory Board members may be elected/appointed to not more than three consecutive terms or six consecutive years, unless the incumbent represents a required category and no other individual with similar qualification is available. Individuals interested in returning to the Advisory Board may be reappointed after not less than a one year period off of the Board.

After serving the three-term maximum or six consecutive years, a member of the Advisory Board may be elected to serve on the Governing Board, based on the needs of the organization. Similarly, a member of the Governing Board who has

reached his/her term limit may be elected to the Advisory Board, based on the needs of the organization.

Except as provided in the Articles of Incorporation or these Bylaws, the term of a Member filling any vacancy expires at the end of the unexpired term that such Member is filling.

Section 5. **ELECTION/APPOINTMENT.** Potential Advisory Board members may be nominated by existing members, members of the health care community, the community at large, members of the Governing Board and any other source(s) deemed appropriated.

Nominations shall be solicited, reviewed and compiled by the Chairperson of the Advisory Board. He/she shall prepare a final ballot for distribution to the full Advisory Board. The ballot maybe distributed in person, by U.S. mail, or by facsimile, any official shared NDN portal or electronic mail at least sixty (60) days prior to the annual meeting. The Chairperson or their designees shall tabulate the returned ballots and report the results of the election 30 days prior to the Annual General Meeting.

Election to the Advisory Board shall be by written ballot. The person with the largest number of votes shall be elected. The Advisory Board shall be elected by a majority vote of the members and ratified by the Governing Board.

The Chair of the Advisory Board, shall be elected by a majority vote of the Advisory Board with ratification by the Governing Board. The Chair shall serve a two-year term but may be elected to successive terms. The Chair of the Advisory Board shall serve as the liaison (non-voting) to the NDN Governing Board. He/she may attend Governing Board meetings and report on the Advisory Board's activities and its progress in improving organ/tissue donation.

Section 6. **VACANCIES.** Vacancies on the Advisory Board will be filled by the Chair of the Governing Board in consultation with the Chair of the Advisory Board. The appointee shall hold office until his/her successor is elected. A vacancy or vacancies on the Advisory Board shall be deemed to exist in case of the death, resignation, or removal of any member.

Section 7. **REMOVAL/RESIGNATION.** Any member who has three (3) consecutive, unexcused absences from a regularly scheduled meeting may be deemed to have resigned from the Advisory Board. To be excused, an absence must be reported at to the

Chair least 24 hours before the meeting.

Any Advisory Board member may resign at any time by submitting written notice to the Chairperson of the Advisory Board.

Any Advisory Board member may be removed with or without cause by the Chair of the Advisory Board with consent of the Chair of the Governing Board.

ARTICLE IV – CONFLICT OF INTEREST

- Section 1. **CONFLICT OF INTEREST.** All Members of the Advisory Board must avoid situations where a potential or actual conflict of interest could exist, disclose the potential or actual conflict of interest to the Advisory Board and abstain from voting on any NDN issue involved with the potential or actual conflict of interest, pending guidance by the Advisory Board following disclosure. "Conflict of Interest" is defined as any situation in which the Member is placed in a position where the Member could exploit the Member's position with the NDN in some way for the Member's personal benefit. Examples of a conflict of interest would include, but not be limited to, accepting personal payment for the Member's selection of vendors to provide goods or services to the NDN, disclosing or using NDN's confidential information for the Member's personal gain, or usurping a NDN business opportunity for the Member's personal benefit.
- Section 2. **DISCLOSURE:** Any actual or potential conflict of interest must be disclosed at the start of each meeting of the Advisory or at any time during the meeting that an actual or potential conflict becomes apparent. The remaining Board members may excuse the conflicted member, or instruct him/her to abstain from voting on the relevant topic.
- Section 3. **COMPENSATION:** No Member of the Advisory Board shall receive compensation for their service as a Member of the Advisory Board. However, Members of the Advisory Board may be paid for services rendered to the organization. Compensation for such services shall be set by the Governing Board. A Member of the Advisory Board performing services for compensation that has been approved by the Governing Board is not acting under a conflict of interest.
- Section 4. **ACKNOWLEDGEMENT:** All members of the Advisory Board must attend an orientation program that includes information on Corporate Compliance and Conflict of Interest.

All Advisory Board members must annually sign an acknowledgement (NDN

Form# QA 5600) attesting to their understanding of the NDN's Corporate Compliance and Conflict of Interest policies. Failure to return a signed form will result in removal from the Board.

Section 5. **CROSS-MEMBERSHIP:** Members of the Advisory Board may not hold voting membership on the Governing Board. However, Advisory Board members may attend in a non-voting, advisory capacity.
