29 Our program to increase collaboration between Vineyard nonprofits started in 2010 when we brought over 35 Arts and Culture organizations together and facilitated the creation of an Arts and Culture Collaborative. We have been a lead member and sponsor. In 2014, they continued to grow and, in partnership with local business, increase cultural tourism. Most of our effort in 2014 was spent developing the Healthy Aging Task Force (HATF) we created in 2013. The HATF has over 70 volunteer members representing more than 36 health, human service and municipal organizations that serve Island elders. There are 7 different work groups developing collaborative programs to address the various needs of our growing elder population. Our Executive Director served as the HATF's Executive Director and 3 of our Board members serve on the HATF's Coordinating Committee. In 2014 we helped the workgroups develop operating plans which were presented at a Community meeting we sponsored and facilitated for over 60 community leaders. We led a major community education and outreach effort including presentations to more than 20 community groups, organizations and committees and the launch of an HATF e-newsletter that goes to over 200 community leaders and interested parties. We also facilitated the start of a Community wide strategic plan for dealing with elder needs. This 3 days process included 35 community leaders that serve Island elders.
