Founded in 1988, the Quality Deer Management Association (QDMA) is a nonprofit wildlife conservation organization dedicated to ensuring the future of white-tailed deer, wildlife habitat and North America’s rich deer-hunting heritage. QDMA’s mission is delivered through its REACH program, which focuses on five core areas: Research, Education, Advocacy, Certification and Hunting heritage. These goals and activities are accomplished through its national office, regional employees and extensive grassroots volunteer network. Since 2006, QDMA has contributed more than \$500,000 to deer research projects throughout the U.S. and Canada, conducted nearly 2,000 educational events, provided expert opinion on nearly 500 proposed policies, regulations, and plans, certified more than 1,300 hunters, landowners and biologists, and mentored thousands of young and first-time hunters. QDMA also provides many direct member benefits including its flagship publication, Quality Whitetails, National Convention, comprehensive website (QDMA.com), Rack Pack youth program, and numerous education and outreach programs. Given QDMA’s history of using science and hunter ethics to guide sound deer management decisions, it is widely considered the most respected and influential whitetail conservation organization in North America.
