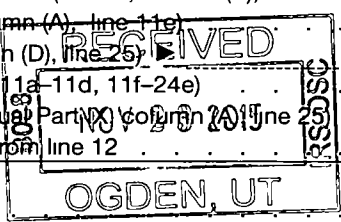

 With the goal of developing an innovative digital library platform for the delivery of ebooks in low bandwidth environments, Library For All focused its efforts on developing and iterating on this technology in Haiti to make knowledge accessible on any device. In Haiti, educational outcomes are incredibly low, with the most recent national survey reporting that schools are vastly under resourced with only 15% of schools having access to a library. Library For All ran stakeholder meetings and partnered with public and private sector organizations to gather user feedback on the design and functionality of the Library For All digital platform. A local content Advisory Board of Haitian authors and educators was constituted to source and review all content added to the digital library collection, and the largest collection of digital content in Haitian Creole was carefully curated, along with content in French and other languages. In September, the first version of the Library For All hybrid application was released and made available to select schools to continue the testing and iteration process. Partnerships were also formed with telecommunications companies and device manufacturers in Haiti, laying the foundation for a scalable rollout of the Library For All platform to schools and educational providers across the country.

 In partnership with local NGO En Classe, Library For All released a version of the Library For All platform in the Democratic Republic of Congo, with the goal of running a pilot at one school to test and iterate on the design and functionality of the Library For All platform and the potential for a national rollout. Educational outcomes in the DRC are amongst the lowest in the world, and in a RTI International 2012 Early Grade Reading Assessment (EGRA) baseline assessment of grade 4 and 6 students, 29 percent of boys and 44 percent of girls could not read one word. Library For All supported En Classe to undertake a six week teacher training course on the use of the Library For All platform. The Library For All platform was populated initially with a curated collection of 50 books. Local government and private companies were engaged with the pilot, laying the foundation for a regional scale up of access to the platform.
