In the annual events, participants get an opportunity to attend and actively engage in discourses, presentations, music concerts. This event helps the individuals follow a righteous and a fulfilling path in every day living in accordance with the Madhwa Philosophy. The income generated in the event is primarily for the conduct of the events and there is no intent to generate profits, as with any event of Bhavaprakashika - All funds are voluntary contributions received primarily to cover the costs of the event itself.
1b	Musical Festival - The Madhwa Philosophy includes a branch of music called "Dasa Sahitya" - this form of music fully supports the Madhwa teachings. There are a few renowned practitioners of this form of music from India and Shri. Vidyabhushana. While Shri. Vidyabhushana visits USA, we take advantage of this opportunity for all our group members to participate in music sessions geared towards learning the art form as well as taking valuable messages related to Madhwa Philosophy - the funds collected are primarily to fund the organizing the musical event in various cities and all contributions are voluntary.
1c	During the year and during certain events, group members contribute some amounts voluntary - these amounts help in supporting the overall purpose and goals of Bhavaprakashika for its activities. These contributions are used for expenses related to booking of halls, buying groceries and vegetables, and for the logistical costs of organizing these events. There are no fees or appearance money payments to the Guru or to any of Bhavaprakashika volunteer. Every event is organized primarily for furthering the spiritual knowledge and understanding of the members with the help of several scriptures including the Bhagavad Gita.
1d	Based on the Madhwa Philosophy the head and founding guru is Madhwacharya. Under his lineage we have Saints that have followed Shri Madhwacharya's teachings - These gurus include Shri Vadiraja Theertharu, Shri Raghavendra Theertharu and Shri Ragothama Theertharu, to name just a few. Every year during the anniversary dates of these Gurus, Bhavaprakashika members gather together and celebrate the unique teachings of these Gurus and the message that they have passed on to the Madhwa followers. These events are typically hosted by individual members in their residences as a mark of respect to the Saints whose anniversary is being celebrated and is hosted voluntarily. The Contributions received from members during these events are primarily to support the expenses of Bhavaprakashika activities and events throughout the year.
