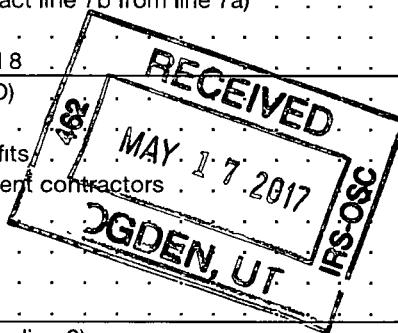

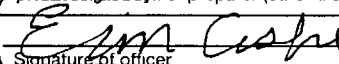

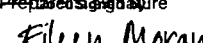

We aim to enhance stewardship of the environment by providing the most accurate scientific information possible to those individuals and organizations responsible for environmental policy-making, by bringing the environmental consequences of human actions to the fore of public discourse, and by enhancing public understanding of the environment and the effects of human activities upon it

Form 990-EZ, Part III, Line 28 Ocean Noise - Oceans Initiative carried out important marine conservation work to assess the impacts of ocean noise on whales, dolphins and fish The results of the project were shared in various forms, including scientific meetings, social media, public lectures, and meetings with stakeholders and marine wildlife managers The work accomplished during 2014 has formed a foundation for future work in the program area.

Dolphin Conservation - Oceans Initiative received a grant from National Geographic to investigate the impact of mammal-eating killer whale predation on the population dynamics of Pacific white-sided dolphins We collected population data on the dolphins and found evidence for predation impacting the health of the dolphin population. These results were compiled into a final report for National Geographic, will be shared in a popular article, and are currently being prepared for submission to a peer-reviewed scientific journal

Killer Whale Conservaton - Oceans Initiative received a grant from the Puget Sound Institute in partnership with the University of Washington in Seattle The aim of the grant and the research carried out placed endangered killer whales and endangered salmon into a socio-ecological framework along with fishing and whale watching, to investigate the impacts of these various activities on the conservation of salmon and whales, and the economic cost associated. One of the outputs was a tool that managers can use to explore different management scenarios and the impacts on the ecosystem and economy of the Salish Sea We presented the results in a live meeting with stakeholder and other scientists, wrote a final report, and created a video to explain the project. The results are being prepared for submission to a peer-reviewed journal
