Management has analyzed the tax positions taken by the Credit Union and has concluded that as of December 31, 2014 and 2013, there are no uncertain positions taken or expected to be taken that would require recognition of a liability of disclosure in the financial statements. The Credit Union is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax period in progress. Management believes it is no longer subject to income tax examinations for years prior to 2011.
