Since its inception in 1950, the Foundation has contributed millions of dollars towards community betterment in the form of scholarships and grants, historic home and archive, and the development and operation of Tumwater Falls Park.

Operation of Tumwater Falls Park, one of the most popular private parks in Washington State, for the benefit of over 250,000 annual visitors. The urban oasis features waterfalls, river, woods, hiking and historical sites adjacent to the state capitol of Olympia.

Awarding over \$105,000 in scholarships to 20 talented and deserving students by the Olympia Tumwater Foundation education committee. Scholarships are offered on the basis of both achievement and need to Thurston County residents attending college within the state of Washington. The Foundation also granted over \$8,000 to 6 local school districts and early childhood programs for innovative classroom projects.

In 2014 the Foundation formed a robust history program with the hiring of a public history manager and archivist.
