

Activities include Bible conferences, Bible studies, Benevolence work, training programs, and helping orphanages.

We helped 24 different churches and ministries plan and facilitate 24 different Bible Conferences in 2014.

A total of 717 people attended these conferences. During these conference we provided devotionals, Bible teachings, facilities, and meals. Groups that attend these conferences come from a variety of churches which include men's groups, women's groups, leadership groups, families, and missionary groups.

We have a interdenominational Sunday Evening Service each week along with different weekly Bible Studies each week that are held in various homes of individuals in our area. Our Sunday evening services average around 25 - 30 people with about 40 different people attending regularly. *We received \$31,059. In general contributions from these services in 2014 over the year, which the instructions say not to include these as revenues since they were contributions.

We are involved with various ministries and individuals in other countries who are like minded as we are and are preaching the gospel of Jesus Christ in India, Nepal, Canada, Papua New Guinea, France, and Poland. Most of our outreach involves the nation of Nepal. Approximately every 4 months we take 10 destitute young women who have hardly any education and bring them to Kathmandu, Nepal and send them through a training program so that they can become seamstresses and run their own business. We pay for their room, board, and tuition at Rescue Training and Development Center. We are currently on our 14th group of girls. We also help care for street children in Kathmandu, pay for schooling of some orphans and help some Nepali pastors financially. We support a doctor who works in a remote area of Papua New Guinea and help support a Christian ministry called Frontier Lodge in Alberta, Canada. We also help indigent people in our community through a ministry called Cafe Repair which helps those who are widowed, injured, sick, unemployed, etc. and we help them with repairs of cars, homes while they are in a difficult circumstance financially and health wise. **All of these ministries are ran from contributions that we receive which for 2014 totaled \$71826., which the instructions for this form say not to include these as revenues since they were contributions.

Part I - Every 4 months a ministry called Rescue and Training Development Center picks 10 young destitute women from villages in Nepal

and brings them to Kathmandu. RTDC helps educate them and teaches them how to sew and run a seamstress business. We pay for the room, board, and tuition for those 4 months. During this time they are also taught about the love Jesus Christ has for them.

At the end of 4 months they return to their villages to begin their businesses. We are now on our 14 group of students and have had a very high success rate. One of our board members attends the graduation every 4 months and we are in constant communication with the directors of RTDC who send us pictures and updates monthly. www.nepalrtdc.com

We have also involved ourselves with sending some older orphan children, whom we have some personal knowledge of, to university in Nepal, India, and the Philippines by paying their room, board and tuition. Some of these students are from orphanages we have supported in the past, while others are children of indigent people whom we know. These students are also followers of Christ and are committed to sharing the gospel of Jesus Christ. We monitor their progress via email, personal visits when visiting Nepal, and communicating with their parents, pastor or orphanage parents.

Part 1 - Frontier Lodge is a ministry located in Alberta, Canada dedicated to sharing the gospel of Jesus Christ, using creation as the way to share the gospel of Jesus Christ with those taking part in their programs. Some of the staff at Frontier Lodge grew up being part of our Sunday Church Services and participated in the ministry here. They are like minded in purpose and attended the same Bible School as one of our board of directors. We monitor the ministry through a board member visiting the ministry once or twice a year, through email, and twice a year they return to our area and share about what is happening at Frontier along with blogging. www.Frontierlodge.ca

Part 1 - A doctor who use to attend our church services is now working in Papua New Guinea with a ministry called Wycliffe Bible Translators and is providing medical services to both the natives and other missionaries in that area. at 5%, payable monthly and secured with a mortgage on the residence and rental property of Greg and Teresa Miller. All documents
