Advocacy - ADWAS has advocates on staff to assist people who are victims of domestic/sexual violence. Services are free of charge and available to people who are Deaf, DeafBlind or hard of hearing. Most are residents of King, Pierce or Snohomish County. ADWAS also serves those from around the state who are able to come to ADWAS for services. During 2014, ADWAS served 124 adults and 36 children through our Supportive Housing Program, 9,000 as part of our outreach and education program, 1,316 callers to our National DV Hotline Counseling - The counseling program offers victims of domestic violence and sexual assault the following services: Short-term crisis counseling, On-going individual/family therapy related to domestic violence & sexual assault, Group counseling related to childhood sexual assault and domestic violence, Psychosocial assessments and evaluation of sexual abuse of children, Client advocacy and referrals.
