Client Services provided medical case management, in Pierce and Thurston Counties, to over 750 clients in 2014, helping them access medical and dental treatment, helping them stay on their HIV medications, and providing in-house screening for mental health and substance abuse services. Nutritious meals are available for qualified clients through collaboration with Chicken Soup Brigade and Emergency Food Network.

Oasis Youth Center transforms the lives of lesbian, gay, bisexual, transgender, and questioning youth ages 14-24 by creating a safe place to learn, connect, and thrive. Oasis offers 24 drop-in hours per week during after school and evening hours. Oasis programming includes a weekly peer support check-in, HIV prevention, healthy relationship, wellness, and health promotion activities and services, crime prevention programming and crime victim advocacy, and youth leadership development. Oasis serves over 500 youth annually.
