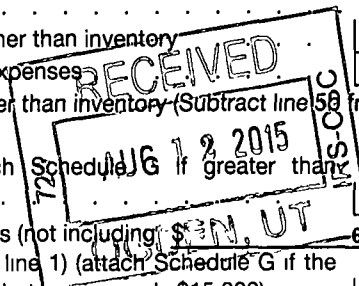

This has been the case since the stock donation; PA has never used any dividends or interest or sold any of the stock for day to day operations of any of its programs. PA received \$4.00 in interest from a general savings account: \$4 + \$44 = \$48 investment income.
