 Attain Housing provides safe low cost housing for families facing homelessness. Professional case managers provide financial counseling, life planning, goal setting, structured programs and emotional support to help families achieve their goals. Attain Housing's community network ensures every family has the resources, education, life skills training and ongoing support needed to achieve self-sufficiency.

 Transitional Housing is a 24 month program that provides housing or rental assistance along with case management support to families at risk of homelessness. The program outcome is to provide each family with the skills and support they need to secure and maintain permanent housing.
 In 2014 50 families were housed comprised of 147 family members.

4b (Code) (Expenses \$ 107379 including grants of \$) (Revenue \$)
 Permanent Housing supports formerly homeless families with a stable housing situation with affordable rent (based on a per cent of clients gross income).
 In 2014 Attain Housing served 5 permanent families and 11 individuals.

4c (Code) (Expenses \$ 10500 including grants of \$) (Revenue \$)
 Community Service
 These programs provide support for families in our housing as well as individuals and families in the community at risk of homelessness through holiday assistance and meal programs.
 Community supper, operated one day a week 52 weeks a year, provides a nutritious and welcoming family style dinner. More than 2246 meals were served in 2014.
 Our holiday assistance program supported 93 families (302 individuals) with Thanksgiving dinner and 284 families and 86 individuals with December gifts.
