We provide relationship skills classes and networking opportunities for parents, and leadership and job training for LGBTQ youth. The NW Network hosts the National LGBTQ Capacity Building Learning Center in partnership with NCAVP. We conduct strategic research and evaluation to build the knowledge needed to end gender violence across the life span. We foster coalitions and provide training and technical assistance in Washington State and around the country to improve support and access for survivors and build community capacity for change. We work in a broad movement for racial, economic and gender justice.
