Training is made available to an array of individuals and counselors through classes, conferences, and certification for professional counselors. The program strives to provide specialized training for counseling problem gamblers and family members to increase counselors' effectiveness in helping individuals overcome a gambling addiction or its negative effects on the family. The program also offers certification and training to individuals who are responsible for furnishing treatment services to those who have been identified as having a gambling addiction. Responsible Gaming Training is available for gaming industry employees at both the management and frontline staff levels.

4b (Code:) (Expenses \$ 207,693 including grants of \$ 120,775) (Revenue \$ 0)Treatment/Therapeutic Justice:

The treatment and therapeutic justice program includes both residential and outpatient treatment services for problem gamblers. These treatment services are available to all individuals within the state who are striving to overcome gambling addiction. Outpatient treatment services are also available for family members affected by gambling addiction and living in Washington. A treatment provider manual has been developed with tools and forms for service providers to deliver services to problem gamblers.

4c (Code:) (Expenses \$ 193,668 including grants of \$ 8,748) (Revenue \$ 45,673)Education/Outreach/Youth Services:

Public education focuses on helping individuals and the community at large to identify and prevent gambling addictions. This is accomplished by making problem gambling information and resources available to the general public including resources for treatment and support services. The information is available via the Council's website in electronic download as well as in print and video form. The Council operates a speaker's bureau to conduct public awareness presentations throughout the state. The bureau is available at most venues including schools, businesses, civic councils, and agencies within Washington State and other regions. The Youth Services program is designed to assist youth in making healthy choices and reduce risky behaviors. Youth services also includes an arts-based program, New Directions/Youth Arts Grants, to help youth become aware of the potential negative effects of gambling addictions and to also become aware of alternate healthy choices in entertainment and recreational activities.

Changes to the Articles of Incorporation and By-Laws are as follows:

1. The name of the corporation is amended to include the DBA Evergreen Council on Problem Gambling.

2. Article III - Purposes, Section I of the Articles of Incorporation were amended to read as follows:

"The corporation shall operate exclusively for charitable and educational purposes consistent with the provisions of the Internal Revenue Code of 1954, Section 501(c)(3) as amended, to provide a state-wide voluntary council composed of groups and individuals from the public and private sectors who share a mutual concern for the impact on both individuals and society associated with problem gambling. The Evergreen Council on Problem Gambling is dedicated to increasing public awareness of problem gambling, expanding the availability of services for those affected by problem gambling, and encouraging research and programs for education, prevention, treatment, and responsible gambling."

3. Article V - Directors was amended to read as follows:

"This corporation shall have no less than five (5) directors and no more than eleven (11) directors as determined in accordance with the By-Laws of the corporation. A current list of directors shall be maintained at the corporation's office, as listed above in Article IV.

The term of directors and content of the board of directors shall be as determined by the By-Laws; provided, however the board of directors should consist of at least one (1), but no more than three (3) directors at any one time from each of the following groups: recovering problem gamblers, employees or representatives of organizations involved in the gambling industry, and treatment providers. The purpose of this limitation is in furtherance of the council's objective of remaining neutral on gambling issues."

The Amendments to the By-Laws include the merging of the titles and duties of the Secretary and Treasurer into one office, that of the Secretary-Treasurer, as well as the number and composition of the board, as documented above.
