Eastside Baby Corner (EBC) provides basic health, safety, nutritional and comfort items for all babies and children in need, birth to age 12, who are living within our area of operations and are currently being served by a social service, educational or health organization in our network EBC helps diminish the damaging effects of toxic stress stemming from poverty and other adverse childhood experiences For 25 years, we’ve used our expertise to supply formula, diapers, food, clothing, car seats, beds, school supplies and more to keep kids nourished, secure and healthy, at no cost to families or to our provider partners Our strength comes from deep community participation, from volunteering to the donation of goods EBC is the only organization in greater east and north King County to provide this service for children who are living at or below the poverty level EBC works as a safety net for both the human service providers and for the families they help

EBC has one primary program - the collection and distribution of goods to children ages birth to 12 Our process begins with the intake of items donated by members of the community at our distribution hubs in Issaquah and Bothell, or at drop off locations in Redmond and the Issaquah Highlands All items are then sorted and bundled for clients by volunteers and distributed to low-income families who are identified and pre-screened by partner-providers such as case managers, public health nurses and school counselors We collaborate with approximately 200 partner providers, who work in 169 programs within 50 organizations Volunteers are fundamental in carrying out our organization's mission, about 2,500 volunteers donated just over 28,000 hours in 2014 In 2014, EBC distributed thousands of essential goods, including almost 800,000 diapers, 3,844 cans of infant formula, 8,118 Big Bundles of clothing to kids and expectant mothers, 1,324 car seats and over 7,000 baby food meals EBC provides immediate, tangible help for families in need, we also "help the helpers " The goods provided by EBC removes barriers to service for providers - rather than spending time and resources to find the basic goods families need, case managers can use their professional expertise to help families with goal setting, job skill development, mental and physical health support and parenting and life skills improvement
