SMALL BUSINESS ORGANIZING. Main Street Alliance, a project of AJS, is a national network of state-based small business coalitions that works to create opportunities for small business owners to speak for themselves about issues that impact their businesses, workers & communities. MSA worked to build the voice of small business owners across the country through a leadership development program focused on a better understanding of issues including tax fairness, money in politics, immigration reform, health care, retirement security & job quality issues like earned paid sick leave & minimum wage. MSA national & affiliate staff spoke one-on-one with thousands of small business owners, & worked to cultivate small business owner leadership in the media, in public forums like the White House Summit for Working Families, & in dozens of small business roundtables & business-to-business engagement opportunities. Significant victories include: small business support for Seattle's \$15 minimum wage, & NJ MSA put Gov. Christie in the hot seat for mismanaging Superstorm Sandy recovery grants.

PUBLIC EDUCATION & COMMUNITY ENGAGEMENT ON ISSUES. AJS supported community organizations in their work to educate the public about access to living wage jobs, the benefits of Medicaid expansion, ending racial health disparities, the foreclosure crisis, skyrocketing student debt, & other issues. This education led to community engagement including: a letter signed by over 1,000 small business owners that supported executive action to keep immigrant families together; a rally of 227 people from 10 states calling for relief from rising student debt burdens; nonpartisan voter registration of 7700 people in ID, WA, OR & MT from low-income, immigrant & native communities; mobilization of Native people in MT to successfully call for an audit of private prison practices; education of 500 immigrants about administrative opportunities to fix their status; over a dozen mobilizations to support solutions to the foreclosure crisis in Seattle; activities in 4 states highlighting the need to expand Medicaid; & education, outreach & enrollment work on the Affordable Care Act & Medicaid in 6 states.

LEADERSHIP & STAFF TRAINING & ORGANIZATIONAL DEVELOPMENT. AJS supported community organizations, members & staff in issue training & leadership skills development. We held 22 trainings with more than 1000 participants. These included issue trainings on immigration, racial justice, money in politics, health care, mass incarceration, & other issues. We held skill trainings for staff & affiliates on community organizing (including 3 4-day trainings- one in Spanish- with 55 new staff & leaders, & a 4-day training with 31 Native organizers). We trained over 200 people at our national conference on a combination of skills & issues related to racial & economic justice. We held state-based trainings in CO, ME, WA, NY, ID, OR, MT, & VA. AJS launched a new training program, the Online Community College for Community Organizations, that used interactive software to enhance the education efforts of our affiliates & to connect leaders across the country in shared curricula. The program included a facilitation workshop to prepare the training team & 3 sessions that trained over 175 leaders.
